C. Health Guarantee

Maremma Sheepdogs are considered a Livestock Guardian Dog and placement to working homes will be prioritized, unless other wise stated within this contract.

- 1. Dog is purebred. Pedigree is correct and given at the time of sale. Dog is able to be registered with the MSCA.
2. Dog will be free of hereditary crippling defects visible by 6 months of age. Dog will be replaced, provided dog is returned to Seller, at the Buyer's expense, within fourteen days of discovery of such hereditary crippling defect.
3. At the option and expense of the Buyer, Seller will provide a 72 hour health guarantee from the time of pick up, upon examination by a vet acceptable to both parties. Should dog be found to be unsound at the time of examination, i.e. a health guarantee, Seller will have the option to either provide a 100 % refund of the purchase price to Buyer, providing dog is returned to Seller or to replace the dog with a similar puppy/dog, providing the first dog is returned to the Seller within 14 days. Arrangements and cost of transportation are the responsibility of the Buyer.
4. For a period of 7 days, the puppy can be returned for a full refund for any reason. Arrangements and cost of transportation are the responsibility of the Buyer.

NO OTHER WARRANTIES EXPRESSED OR IMPLIED

5. If the Buyer ever must give up ownership of the dog, for whatever reason, at whatever age, said dog must be returned to the Seller, at the Buyer's expense, unless other agreements are made.

D. [] Full Registration (breeding rights) or [] Limited Registration (no breeding rights) Option

We care for our dogs and for the entire breed of the Maremma Sheepdog. Because of our concern, we make this agreement to help ensure that dogs sold with Full Resigtration will continue to promote the best qualities of the breed. If granted Full Registration rights, we expect you to health test your breeding dogs to ensure they are sound. A dog purchased dog with Limited Registration will not be able to have their offspring registered with the MSCA. It is recommended to not have this dog neutered or spayed until they reach maturity, or 24 months of age.
